WHO IS ICLEI?

The International Council for Local Environmental Initiatives (ICLEI) is an international democratic association of local governments implementing sustainable development. Its mission is to build and serve a worldwide movement of local governments to achieve tangible improvements in global environmental and sustainable development conditions through cumulative impact of local action.

More than 400 cities, towns, counties, and their associations comprise ICLEI's membership representing over 300 million people from around the world.

ICLEI A/NZ focuses on two elements. The first element is our capacity building campaigns, such as the Cities for Climate Protection Campaign™ and the Water Campaign™; and the second element is our sustainable development

activities, such as our Green Purchasing Pilot Program approach and our Triple Bottom Line training system.

ICLEI's approach includes a well tested and strategic Milestone Framework and quantification methodology, combined with technical, political and promotional support, training workshops, access to a range of resources and materials, and multiple networking opportunities at local, national and international levels.

In delivering our services, ICLEI works with many competing factors, such as funding constraints, and multiple partner organisations, which can limit campaign and project development to specific geographic locations. However, we continue in our efforts to increase accessibility of our programs and services to councils across the Australia and New Zealand region.

KEY ACHIEVEMENTS IN 2002

Cities for Climate Protection (CCP[™]) Australia Program – Expanded to 168 councils (January 2003) covering over 65 percent of the population.

CCP[™] Rural Victoria – New component of CCP[™] Australia established, focused on reducing greenhouse gas emissions from associated land use activities in rural local governments.

Sustainable Transport Unit – Established at the ICLEI A/NZ Office to focus on practical transport activities that reduce greenhouse emissions and improve urban liveability.

CCP[™] New Zealand Campaign – Approval granted from New Zealand (NZ) Cabinet to establish CCP[™] NZ in 2003.

The Water Campaign™ Australia – Commenced in 2002 involving 25 councils (January 2003), using ICLEI's performance based model and the new on-line software.

Triple Bottom Line Toolkit – Completed in conjunction with the City of Melbourne, and further developed with the Cities of Wyndham and Coffs Harbour.

Green Purchasing Pilot Program – Commenced in late 2002 with ten pilot councils in four states working on program elements and tools development.

World Summit on Sustainable Development – ICLEI A/NZ completed a two-year preparation period in the Asia Pacific region with local government culminating in our facilitation of a four-day conference and the launch of 'Local Action 21'.

Local Action 21 Unit – Established at the ICLEI A/NZ Office to deliver the programs, projects and activities that form the Local Action 21 Toolkit.

ICLEI Membership – Expanded to 58 Councils. ICLEI A/NZ developed additional resources and benefits for ICLEI Members.

Host Agreement – Re-negotiated with the City of Melbourne for a further three years.

ICLEI expanded to 21 staff – Providing technical, program, and political support to our participants and members.

POYECTIONS

CCP™ CAMPAIGN

ICLEI developed the innovative Cities for Climate Protection™ (CCP™) Campaign in 1993 to motivate and empower local governments worldwide to take action on climate change. CCP™ is a performance-oriented campaign that offers a framework for local governments to reduce global warming emissions, and a mechanism to foster improved liveability in municipalities.

More than five hundred local governments are participating in the Campaign around the world currently representing 8% of global greenhouse gas emissions, and the numbers are growing internationally.

CCP™ AUSTRALIA PROGRAM

The Australian arm of the Campaign was launched in 1998, and has experienced rapid growth due to the enthusiastic participation of Australian councils. The Australian CCP™ Program is delivered by ICLEI in collaboration with the Australian Greenhouse Office (AGO).

Achievements to Date

There are currently (January 2003) 168 Councils participating in the CCP™ Program covering over 65 percent of the Australian population.

CCP™ Australia is recognised as a model which successfully engages local government in voluntary action on greenhouse abatement. It has built the capacity of local government to make the institutional changes at the corporate and municipal levels needed to achieve action on greenhouse issues.

Results from approximately one third of CCP[™] Councils from July 1999 – June 2002 have shown the following benefits:

Environmental Benefit – Abatement of 1.2 million tonnes of cumulative CO2e (carbon dioxide equivalent);

Economic Benefit – Investment of \$56 million in greenhouse abatement; **Social Benefit** – Investment of \$2.6 million in greenhouse job creation.

Participation Benefits

Aside from reducing greenhouse gas emissions, councils joining CCP™ also accrue the additional environmental, economic and social benefits that can result from greenhouse gas reduction. Examples of these benefits include:

- New markets and industries are encouraged, providing local employment and business opportunities.
- Demonstrated local leadership by councils who have a legitimate and vital role in articulating their communities views and acting upon their concerns.
- Opportunities for partnerships with industry, residents and other governments at a regional, national and international level; and
- Additional revenue for councils through energy and other savings.



WHO CAN PARTICIPATE?

At this stage, CCP™ Australia will not be seeking additional participants in 2003. However, recruitment opportunities currently exist in rural and regional Victoria and for Milestone 5 Councils (see CCP™ Rural Victoria section and CCP™ Plus section on page 3).


LOCAL ACTION ADDS UP!

CCP™ PLUS - New Initiative in 2002

Many councils in the CCP™ Australia Program are now progressing towards Milestone 5, and many are already engaging in the next phase of the Program, CCP™ Plus. This new initiative is designed to further assist these advanced councils by providing program elements that support:

- The development of sustainable strategies for continued abatement activities, particularly with a focus on whole-of-council knowledge sharing;
- Deepening greenhouse abatement activity, with a focus in the community sector; and
- Opportunities for knowledge exchange regionally, nationally and internationally.

Participation Benefits

Councils that commit to CCP™ Plus will be eligible to participate in a number of CCP™ Plus elements. The first element offered is the Travel Demand Management (TDM) Assistance Package, focused on deepening abatement in the corporate and community transport sector (see Sustainable Transport section on page 4).





THE WATER CAMPAIGN™

The Water Campaign™ (TWC™) is an international freshwater management program which aims to build the capacity of local government to reduce water consumption and improve local water quality.

The Australian Campaign has the same performance based approach that ICLEI has used successfully with local government in the CCP™ Australia Campaign. It's methodology provides a simple, standardised process for water conservation and water quality improvement, and for monitoring, measuring and reporting performance.

In participating in TWC™, councils commit to progress through five Milestones which will lead towards the sustainable management of freshwater resources. Councils work through the Campaign on three levels:

- 1. Corporate where council have direct control over their own buildings and operations;
- 2. Community where councils have indirect control and influence; and
- 3. Catchment where councils have the greatest ecosystem leverage.

Achievements to Date

TWC™ commenced in Australia in late 2001 with the support of five Pilot Councils: Sutherland Shire Council; and the Cities of Wollongong, Mitcham, Port Phillip and Melbourne. ICLEI has now developed online software that eases the analytical work involved and permits quantitative comparisons among cities within Australia and across the globe.

TWC[™] has strong partnerships in place in Victoria with South East Water, Yarra Valley Water, City West Water, Melbourne Water and the Australian Water Association. Further agreements are being developed with water retailers and universities, to support the Campaign's expansion across Australia.

Participation Benefits

Councils joining the TWC™ will:

- Ensure they are 'walking the talk' as they work with rate payers, partners and stakeholders;
- Demonstrate leadership on water quality and consumption issues to other levels of government and community;
- Accrue financial benefits through water conservation activities, such as the retrofitting of water efficient devices in open space, recreational centres and council buildings; and
- Achieve water quality improvements and support diverse freshwater estuarine ecosystems.

WHO CAN PARTICIPATE?

Recruitment is active in WA, VIC and NSW from Jan-June 2003. Councils from specific catchment regions in SA, QLD and TAS will be invited to participate later in 2003.

LOCAL AGENDA 21 CAMPAIGN

The Local Agenda 21 (LA21) Campaign seeks to achieve tangible results and increase standards of performance at the local level in order to achieve sustainable development. Since its establishment in 1991 in response to the Rio Earth Summit, more than 215 cities in 52 countries have participated in ICLEI LA21 activities.

After a decade of the Local Agenda 21 process, the local government community has agreed to a new toolbox of quantifiable actions, called Local Action 21. This will be the implementation mechanism of the Local Agenda 21 vision for the next decade. The ICLEI A/NZ Office has already commenced its implementation of Local Action 21 by establishing the following programs:

- New Leaders in Sustainability:
- Accelerate Now!:
- Triple Bottom Line (TBL) Toolkit;
- Green Purchasing Pilot Program; and
- **EcoBUDGET Pilot Project.**

NEW LEADERS IN SUSTAINABILITY - New Initiative in 2003

'New Leaders in Sustainability' is in response to a call from our participants for integration across council operations in many areas of environmental concern. It is the first leadership management program focussed on the Australian local government sector, providing a unique learning partnership for local government managers. The first phase of this program will be delivered by ICLEI, hosted by the City of Melbourne and auspiced by the Council of Capital Cities Lord Mayors (CCCLM).

Participation Benefits

Key outcomes for participants include the:

- Development of a peer network supporting sustainability leadership;
- Promotion of integration tools for sustainability programs; and
- Opportunity to meet with those at the forefront of environmental management and sustainable development in government, industry and business.

Two streams will be offered:

CEO Stream: Focused on the needs of experienced local government CEOs who wish to challenge their own practices and that of their councils with new millennium thinking and cutting edge action in mind.

Middle Management Stream: Focussed on middle managers who are experiencing the reality of current management constraints and balancing budgets, but who wish to be exposed to new ways of managing for the future.

ACCELERATE NOW! - New Initiative in 2003

After the WSSD September 2002, ICLEI has focussed on the need to accelerate the sustainable development implementation of the Local Agenda 21 vision. ICLEI is proposing to do this - in concert with as many partners as possible - by focusing on key councils that have put into place significant political support, have begun implementation of measurable programs such as CCP™, and are familiar with developing significant cross-sectoral partnerships.

The initiative will work with local government authorities in Australia as well as relevant state and national agencies. The private sector has also expressed a strong interest in utilising this dynamic opportunity-seeking approach to benefit both their organisation and the community in which they operate. Many of these organisations are interested in developing new models of working with local governments to encourage co-operation and resource sharing.

Participation Benefits

Councils interested in accelerating their ICLEI campaign goals and strategies will benefit greatly from this initiative. ICLEI will be seeking councils from around Australia who are interested in bringing forward existing targets, such as those based in the CCP Campaign, as well as their environmental management systems and corporate plans. These councils will be supported to refocus their efforts and resources to achieve quantifiable action.

TRIPLE BOTTOM LINE - New Initiative in 2002

Triple Bottom Line (TBL) is a framework to review environmental, economic and social performance. TBL can be viewed as both a reporting mechanism (e.g. information presented in annual reports) and/or an approach to decision making that can be applied across council activities (e.g. the use of decision making and reporting tools to understand the economic, environmental and social implications of decisions).

ICLEI A/NZ is working with local governments in the development of TBL decision making tools and reporting mechanisms, as well as offering training packages to support the implementation of the tools within councils.

Achievements to Date

ICLEI and the City of Melbourne developed and produced the 'Triple Bottom Line Toolkit for Local Government'. The Toolkit can be downloaded at http://www.iclei.org/anz/tbl/tbl.htm

ICLEI has also engaged with Coffs Harbour City Council to develop a Sustainable Assessment (SA) Tool specific to Coffs Harbour's strategic direction.

Other key decision making points at which TBL tools could be applied include corporate planning, capital works, purchasing, contracts, tenders, planning, budgeting and many others. ICLEI A/NZ aims to develop TBL tools for these areas in the future with councils that are working towards a comprehensive TBL framework.

GREEN PURCHASING PILOT PROGRAM - New Initiative for 2002

Green purchasing involves utilising products and services which have the lowest possible environmental impact during their lifecycle. Hundreds of local governments worldwide are implementing green purchasing policies in order to:

- Contribute towards improved environmental conditions;
- Influence the creation of sustainable markets and cleaner production processes; and
- Save money by engaging in smarter purchasing procedures.

As part of the Local Action 21 Toolbox, the Green Purchasing Pilot Program offers a process for the implementation of green purchasing, using a set of product-specific tools and providing opportunities for joint purchasing.

Achievements to Date

The Green Purchasing Pilot Program began in October 2002 and now has 10 Australian councils participating. So far, ICLEI has identified:

- Criteria for a sound green purchasing policy; and
- A set of products and services that will generate a high environmental benefit when purchased.

By mid-2003, the following resources will be developed:

- A successful process for the implementation of a green purchasing policy, including product specific tools and opportunities for joint purchasing;
- A monitoring system; and
- Tools to quantify the environmental benefits resulting from the implementation of green purchasing.

Participation Benefits

Councils joining the Program will receive the following benefits:

- An analysis of council's current green purchasing policy, or guidance to establish a green purchasing policy;
- Access to the ICLEI green purchasing process, its product assessment tools, and monitoring and quantification tools;
- Expert support from ICLEI at the elected member, managerial and officer levels to achieve the Program's goals; and
 - National and international recognition for green purchasing achievements.

ECOBUDGET™ PILOT PROJECT - New Initiative for 2002

The EcoBUDGET™ Pilot Project originated in Europe and is currently being translated into a framework for Australian local government authorities. The focus of the Pilot Project is to determine whether the financial budgets of the two pilot councils, Baulkham Hills and Sutherland Shire Councils (NSW), are consistent with their environmental policies. The Pilot Project began by targeting two key operational areas: greenhouse gas emissions and waste management. The objectives of the Project are to:

- Develop ecological indicators for achieving sustainability;
- Identify activities which will impact on natural resource capital;
- Identify offset measures to meet sustainability commitments; and
- Improve resource use efficiency.



Achievements to Date

The intellectual development for the EcoBUDGET™ Pilot Project is now complete and all parties have agreed to the methodology. A draft framework has been produced for waste management at Baulkham Hills Shire Council. The Pilot Project is designed to run for one year, with a decision to continue with EcoBUDGET™ based on a thorough assessment of project objectives and outcomes in late 2003.

Participation Benefits

Applying an EcoBUDGET™ approach will ensure that future decision-making is in keeping with stated sustainable policy commitments, and ensure that the policies in place will protect and enhance natural capital.
